

Terms and Conditions

1. Introduction

By registering for and participating in "The Sacred Feminine Retreat," you agree to comply with these Terms and Conditions, which form a binding agreement between you ("the Participant") and us ("the Organizer").

2. Event Details

- Dates: April 25-28, 2025
- Location: Widiane Resort, Bin El ouidane, Morocco
- Included Activities: Yoga sessions, meditation workshops, meals, and accommodations as specified in "What is Included" section of our website.

3.1. Registration

Registration is confirmed only upon receipt of full payment or the required deposit. A confirmation email will be sent to you.

3.2. Payment Terms

- The total cost of the retreat is **15,000 MAD**.
- A non-refundable deposit of **6,000 MAD** is required at the time of booking.
- The balance must be paid within 20 days of the deposit date. Failure to complete the payment by this deadline may result in the cancellation of your booking without refund of the deposit.

3.3. Payment Methods

Payments can be made:

- By credit card on our website.
- By bank transfer.
- By money transfer via our contact form available on our website.

4. Cancellation and Refund Policy

4.1. Cancellation by the Participant

- Cancellations made more than **5 weeks** before the retreat start date will be eligible for a refund, minus the deposit.
- No refunds will be issued for cancellations made within **5 weeks** of the retreat start date.

4.2. Cancellation by the Organizer

In the unlikely event that we must cancel the retreat due to unforeseen circumstances (force majeure), a full refund will be issued. We are not responsible for any additional costs incurred, except those specified in the "What is Included" section.

5. Accommodation and Meals

- Accommodation is provided in shared rooms with separate beds, managed directly by the Widiwane Resort.
- Meals are included and provided by the Widiwane Resort. Dietary restrictions will be accommodated where possible but must be communicated in advance.
- For any issues related to accommodation, meals, or other hotel services, please contact the Widiwane Resort directly.
- Participants are responsible for any damage caused to the property during their stay.

6. Participant Responsibility

- Disclose any medical conditions or physical limitations prior to the retreat.
- Obtain personal travel insurance, including health coverage.
- Respect other participants and follow the venue's rules and safety guidelines. Disruptive or inappropriate behavior may result in dismissal from the retreat without refund.

Participation in the retreat is at your own risk. The Organizer is not liable for any injury, illness, loss, or damage to personal property that occurs during the retreat.
